ORDER


The above-captioned matter came on for consideration before the Virgin Islands Public Services Commission ("Commission") on October 25, 2005, for the interim assessment of the expenses of the investigation. Pursuant to a proper motion after review of the staff's report and recommendation, the Commission voted that Innovative Telephone Company be assessed the sum of \$30,000.00 pursuant to the provisions of V.I. Code Ann. tit. 30, §25;

NOW THEREFORE, it is hereby

ORDERED, that Innovative Telephone Company pay the sum of \$30,000.00 within twenty (20) days of the date of this order, to be deposited in the Treasury of the United States Virgin Islands in a special account to be maintained and administered by the Commissioner of Finance designated Special Public Utility Deposit Account as prescribed by law.
